As Good as Gold's online transaction processing agent, AuctionPay, uses multiple levels of security technology to protect and encrypt online transaction information including Secure Sockets Layer (SSL) certificates and database encryption, dedicated firewall equipment, file tampering monitoring, intrusion detection, and logging and alerting systems that contact human operators immediately on suspicious activities.
